The cull came as Australia experienced its hottest and driest year on record in 2019, with the severe drought causing some towns to run out of water and fuelling deadly bushfires that have devastated the country's southeast. Camels were first introduced to Australia in the 1840s to aid in the exploration of the continent's vast interior, with up to 20,000 imported from India in the six decades that followed.

Australia is now thought to have the largest wild camel population in the world, with official estimates suggesting more than one million are roaming the country's inland deserts.
