

Kolfage, 38, an Air Force veteran from Florida, Andrew Badolato, 56, a financier also from Florida and Timothy Shea, 49, of Colorado, Acting United States Attorney for the Southern District of New York Audrey Strauss said on Thursday.

The men were arrested on Thursday morning and Bannon will be presented in the Southern District of New York, while others will make their court appearance in their jurisdictions.

"As alleged, the defendants defrauded hundreds of thousands of donors, capitalizing on their interest in funding a border wall to raise millions of dollars, under the false pretense that all of that money would be spent on construction," Strauss said. It was assured to donors that Kolfage, the founder and public face of 'We Build the Wall', would not be paid a cent but the defendants secretly schemed to pass hundreds of thousands of dollars to him, which he used to fund his lavish lifestyle, he added.
