Notice is hereby given that the 37" Annual General Meeting (AGM) of the members of Aro granite-industries Itd. ("the Company") will be held on Friday, September 12, 2025 at 12:30 PM. (IST) through video conference (VC/OAVM), to transact the businesses as set out in the Notice of AGM in compliance with the applicable provisions of the Companies Act, 2013 ("Act") and Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") read with General Circular No. 14/2020 (dated April 08 2020), 17/2020 (dated April 13, 2020), 20/2020 (dated May 05, 2020) followed with Circular No. 02/2021 (dated January 13, 2021), 2/2022 (dated May 05, 2022) 10/2022 (dated December 28, 2022) and General Circular No. 09/2023 (dated September 25, 2023) and the latest being 09/2024 (dated September 19, 2024) issued by the Ministry of Corporate Affairs ("MCA Circular/s") and SEBI Circulars dated May 12, 2020, January 15, 2021 May 13, 2022, January 5, 2023, October 7, 2023 and latest being SEBI/HO/CFD/CFD-PoD-2/P/CIR/2024/133 daied October 3, 2024 issued by the Securities and Exchange Board of India ("SEBI Circular"), without the physical presence of the Members at a common venue.

The Notice of the AGM contains the instructions regarding the manner in which the shareholders can cast their vote through remote e-voting or by e-voting at the time of AGM and join the AGM through video conference (VC) / other audio-visual means (OAVM)

The members holding shares either in physical form or in dematerialized form, as on the cut-off date i.e., September 05, 2025, may cast their vote electronically on the Ordinary and Special Businesses as set out in the notice of AGM through electronic voting systems of CDSL. All the members are informed that:

- The Ordinary and the Special Businesses as set out in the Notice of AGM will be transacted through voting by electronic means.
- The remote e-voting shall commence on September 09, 2025, at 10:00 A.M. (IST).
- The remote e-voting shall end on September 11, 2025, at 05:00 P.M. (IST).
- The cut-off date for determining the eligibility to vote by electronic means or at the AGM is September 05, 2025 and a person who is not a Member as on the cut-off date should treat this Notice for information purposes only:
- Person, who acquires shares of the Company and become member of the Company after sending of the notice of AGM and holding shares and eligible to vote, can follow the process for generating the login ID and password as provided in the Notice of the AGM. If such a person is already registered with CDSL for e-voting, existing user ID and password can be used for casting vote;
  - Members may note that: a) the remote e-voting module shall be disabled by the CDSL after the aforesaid date and time for voting and once the vote on a resolution is casted by the member, the member shall not be allowed to change subsequently; b) the members who have casted their vote by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their vote again; c) the facility for voting through electronic mode shall be made available at the AGM and d) a person whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the AGM.
