Our opinion is not modified in respect of this matter.

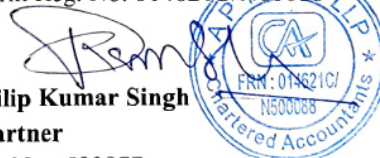

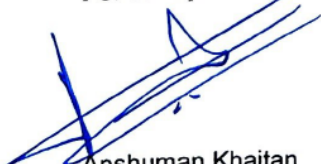
